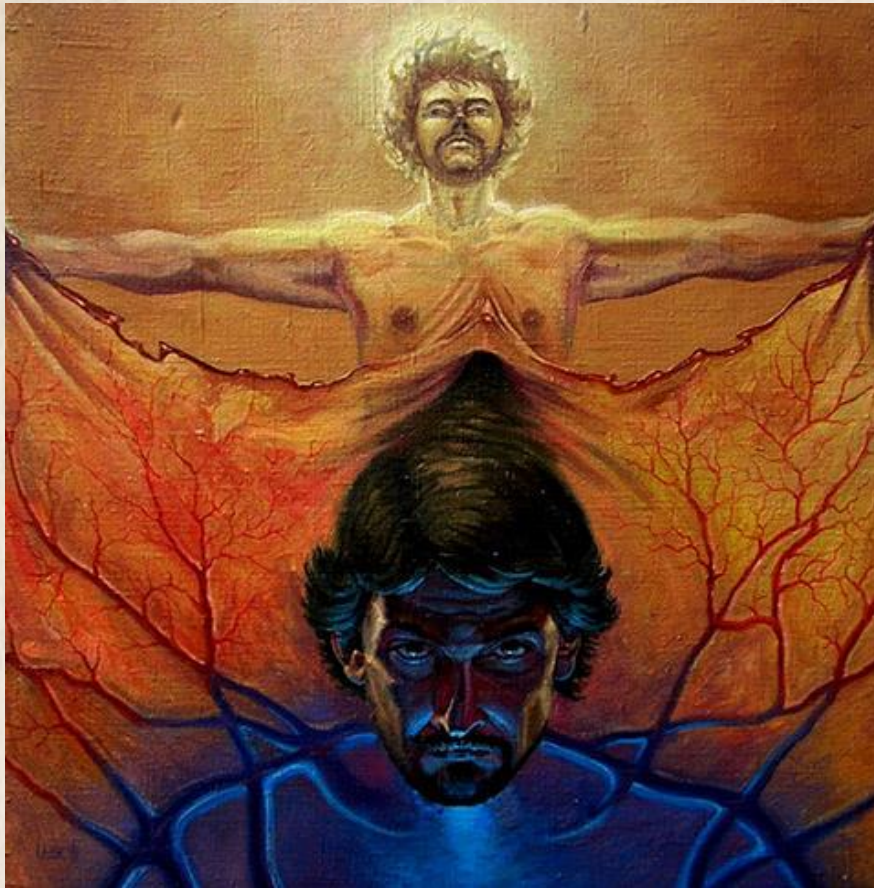

## 1. The brief analysis of the word SOUL

### 1.1. The interpretation of the word SOUL in religious teachings and ancient traditions

The word SOUL has the following meanings in various religious teachings and ancient traditions:

*A soul (from Old Slavic dousha) (Greek. ψυχή, Lat. anima) is the essence, which reflects the divinity of a human being, it gives rise to life, sensations, thinking, consciousness, feelings and will.*

*The ancient Indians characterized a human being as a short-term, but organic combination of the elements, when the soul and the body are closely interrelated ...*

*In the Talmud, the soul is described as the part of a human being created by God.*

*The Kabbalah teachings define the soul as spiritual entity that originates in the higher reason (or world soul) and appears as emanation of the latter.*

The author quoted a small text from Wikipedia, which describes such a concept as SOUL. He did it for a reason; in various religious teachings, there is no clear understanding of the object under the conventional SOUL name up to the present time, the terms are confusive, people use incomprehensible words for describing it.

But still these definitions have much in common:

- The human soul and body are interdependent.
- The soul reflects the divine nature of a human being.
- The soul is created by God.
- The soul originates from God and appears as emanation of the latter.
- Etc.

In the Bible, the word SOUL is tallied roughly 200 times and never used with such words as ***immortal*** or ***eternal***. “Then the Lord God formed a man from the dust of the ground and breathed into his nostrils the breath of life, and the man became a living being.” (Genesis 2:7). According to this verse, the SOUL is understood as merging of the body and “the breath of life”.

Based on materialistic opinions and principles that will not contradict most of the ancient interpretations, let’s try to explain the word SOUL in the next chapters of this book series.



## 1.2. The word SOUL in folk wisdom

Unfortunately, in the English language there are few equivalents for the Russian expressions. Nevertheless, let's try to explain them.

- **After one's heart** (word for word translation of the Russian equivalent: **after one's soul**) — 1) *as a predicate, be to one's liking, to taste. This person is after my heart.* 2) *as an adverb, sincerely, open heartedly. Tell me after your heart, it was you who made all this mess, wasn't you?*
- **With all (my) soul** — sincerely, wholeheartedly. *I wish you success with all my soul.*
- **To live in perfect harmony** (Russian: **to live soul to soul**) — on friendly terms, in tune with smb.
- **In the spirit** — 1) silently, in thought. *In the spirit, he protested against everything done right in front of his eyes.* 2) by nature. *He is poet in the spirit.*
- **With the soul component** — to satisfy one's internal necessities, interests. *An ingenieer began to play the violin with his soul component.*

- **To be crazy about** (Russian: **without soul**) — 1) *about smth/smb.*, to be excited, to love very much. *She is crazy about her husband.* 2) unconsciously, instinctively. *He broke unconsciously into run.*
- **In low spirits** — one who is sick, weak.
- **Body and soul** — entirely, for all intents and purposes. *He is devoted by his body and soul.*
- **In no way** (Russian: **neither by the body nor by the soul**) — in no respect. *In no way he could be guilty.*
- **Not at all** (Russian: **nothing behind one's soul**) — 1) not a bit of it. *There is no money at all.* 2) no strong and sincere convictions. *This writer has no convictions at all.*
- **To give vent to feelings** (Russian: **to give vent to soul**) — to express all your thoughts, everything you cannot afford to remain silent.
- **One's heart isn't in it** (Russian: **one's soul isn't in it**) — to be prone to smth.



- **To load on one's mind** (Russian: **to load on one's soul**) — to cause anxiety, to worry about smth.
- **To have something on one's conscience** (Russian: **to have smth on one's soul**) — to take a moral responsibility.
- **To love with all one's heart and soul** — to love very much, to adore smb.
- **To have no stomach for something** (Russian: **to have no soul for something**) — disgusting.
- **Over head and ears** (Russian: **over soul**) — 1) undesirable overabundance; 2) to be unable to do smth as a result of disgust.
- **To frazzle nerves** (Russian: **to frazzle soul**) — to bring into a state of full exhaustion, to bedevil, to fed up with.
- **To your heart's content** (Russian: **to your soul's content**) — without limits, quite enough.
- **To wear your heart on your sleeve** (Russian: **to wear your soul on your sleeve**) — about a plain-speaking person who cannot withhold anything.



- **To have heart in boots** (Russian: **to have soul in boots**) — to be very frightened.
- **To shed the heart's blood for** (Russian: **to shed the soul for**) — to sacrifice one's life.
- **A dead soul** — a fictitiously listed somewhere; in fact, this one doesn't perform his rights and duties [this expression comes back to the serfdom; in such a way were called dead serfs in census list; "Dead Souls" by Gogol].
- **To get a leg in** (Russian: **to get a soul in**) — 1) to attract smb's attention, to get into confidence; 2) to grill about private life of smb.
- **Heart-to-heart** (Russian: **soul to soul**) (to talk, to carry on a conversation) — in a friendly, sincerely, open-heartedly way.
- **In a heartbeat** (Russian: **easily**) — without hesitation, willingly (to make smth stupid). *He can become a thief in a heartbeat.*
- **To breathe down one's neck** (Russian: **to breathe down one's soul**) — to insistently ask, to bother, to demand.



### 1.3. The definition of the word SOUL in Edgar Cayce's Readings

***“(Q) What is the soul of a body?”***

***(A) That which the Maker gave to every entity or individual in the beginning, and which is seeking the home again or place of the Maker.***

***(Q) Where does the soul come from, and how does it enter the physical body?***

***(A) It is already there. “and He breathed into him the breath of life, and he became a living soul”, as the breath, the ether from the forces as come into the body of the human when born breathes the breath of life, as it becomes a living soul, provided it has reached that developing in the creation where the soul may enter and find the lodging place. ## **1.6. The interpretation of SOUL in modern scientific worldview**

**The word SOUL isn't used in the modern science, since representatives of the scientific community stick to the point of view that a human being doesn't have the object under conventional SOUL name, actually.**



## 2. THE SOUL

### 2.1. The human SOUL

The ENTITY of a human being is able to inSPIRIT a human creature. As a result of incarnation of the ENTITY of a human being into the human BODY, individuals begin to feel the SOUL inside! Individuals, as a rule, don't see the human SOUL, they sensate it.

**The human SOUL is  
an attribute of the human being, manifested by  
individuals as a complex of parameters of the  
PERSONALITY of a human being and the ENTITY of  
a human being that was the basis for its creation.  
Individuals sensate it as a complex during  
communication.**

The bigger number of "sides" (attributes) of the PERSONALITY of a human being and the ENTITY of a human being that was the basis for its creation an individual is able to distinguish, the more complex will be for him the human SOUL he is cognizing.

## 2.2. Birth of the human BODY

A FETUS is the part of a woman's body as long as it is connected to it by the umbilical cord, i.e. A FETUS AND A MOTHER'S BODY are a single whole. A fetus grows in size as a result of the mother's nutrition, reacts to changes of her body parameters and her thoughts, etc.

But once a FETUS appears outside of the mother's body and the umbilical cord will be cut, i.e. THE BODY of a fetus will be separated from the mother's body and this will be the moment when a new object under the conventional **the BODY of a new human being** name will be created.

*"The umbilical cord (also called the navel string, birth cord or funiculus umbilicalis) is a conduit between the developing embryo or fetus and the*



*placenta. During prenatal development, the umbilical cord is physiologically and genetically part of the fetus and (in humans) normally contains two arteries (the umbilical arteries) and one vein (the umbilical vein).*

*The umbilical cord in a full-term neonate is usually about 50 centimeters (20 in) long and about 2 centimeters (0.75 in) in diameter. This diameter decreases rapidly within the placenta. The fully patent umbilical artery has two main layers: an outer layer consisting of circularly arranged smooth muscle cells and an inner layer which shows rather irregularly and loosely arranged cells embedded in abundant ground substance staining metachromatic.”*

**The human BODY is  
an object coming into the world at the moment of the  
cord cutting (navel string cutting), which connected a  
FETUS with the mother s body.**

After that, the ENTITY of a human being can incarnate into the new human body under conditions of the basic embodiment, since from this moment the BASIC EMBODIMENT is possible.

Why is it so?

In the BODY of a pregnant woman there already exist the incarnated ENTITY of a human being. Until the end of a childbirth, she seems to control the condition

of a FETUS as the part of her body. But after cutting the umbilical cord, appears a new human BODY with unique DNA and unique frequency response of the resonant circuit.



Simply said, imagine a television station, which simultaneously broadcasts an unlimited number of TV programs, each of it has its own frequency. There is also an unlimited number of television receivers, each of which can receive TV programs only on a certain unique frequency. As soon as any of these receivers are turned on, a certain TV program will automatically be shown on its screen.

### 2.3. The incarnation of the ENTITY of a human being into the human BODY

As a rule, an object under the conventional name **the ENTITY of a human being** incarnates into **the human BODY** immediately after its coming into the world. This ENTITY should take control over the new body of a human being.

At any moment of time, beginning with birth of the human BODY and ending with the moment of its death (killing), the ENTITY of a human being can incarnate into the free BODY of a human creature (unoccupied by another ENTITY of a human being) on condition of the main incarnation.

Usually this happens immediately after cutting the navel string (umbilical cord) of a newborn.

Unusually means at any time, when the main ENTITY of a human being left his body. This can happen if the human body was fatally damaged, so, it began to function improperly. As a result, the human BRAIN worsened the parameters of connection between the ENTITY of a human being and his/her BODY (changed the Q-quality of the resonant circuit) and the resonance either immediately disappeared or was gradually disappearing. Everything depends on the degree of damage to the human Brain.

It worth mentioning that scientists have already described it in their studies.

They noticed that **the ENTITY of a human being**

*“...uses a new body at any time during impregnation and birth, and sometimes one month from the birth. Of course, there can be exceptions from the rules. But nature had to foresee the instant appearance of the ENTITY of a human creature in the BODY being born, as every byte of information stored in the MEMORY (CONSCIOUSNESS) of the PERSONALITY of a human being is able to provide more confident survival of human beings and their evolutionary development.

**The ENTITY of a human being is able to incarnate into the human body on condition of the main embodiment at any time it wants, beginning with cutting the navel string (umbilical cord) and ending with death (killing) of the human BODY; with a provision that there is no another entity of a human being inside this body.**



Once the ENTITY of a human being is incarnated into the human BODY on the conditions of the main embodiment, individuals will begin to manifest the PERSONALITY of a human being in this body, which will be perceived (manifested, sensed) by other individuals as “appearance” of the SOUL.

So, ancient people were right to call EMBODIMENT as “SPIRITUALIZATION”:

*“TO INSPIRIT, to inspirit smb, to inspire, to put one’s heart, to grant the gift of life; | to spirit up, to pick oneself back up, to see life (soul) inside yourself, to revive; | to ignite. Inspiration.”*

The new interpretation of old terms is the following:

**AN ANIMATE (A SOULFUL) –**

**a subjective characteristic of the object’s body, the SOUL of which individual is able to sense.**

**AN INANIMATE (SOULLESS) –**

**a subjective characteristic of the object’s body, the SOUL of which individual is unable to sense (without SOUL).**

## 2.4. Incarnation of the ENTITY of a human being form the human BODY

The ENTITY of a human being doesn't "go out of" the human body. It either "appears" inside it or "disappears" from it. A resonant circuit leads to resonance! No resonant circuit – no resonance! And that's all ...

Fascists were about to understand this process when conducted various experiments (the experiments on prisoners in concentration camps during World War II). They tied a prisoner to the bed and drilled his skull until he went faint, and then procedure was abruptly interrupted. A prisoner came to himself and was forced to talk about his "near-death experiences", believing that "the Self" of a human being goes out of the BODY during this procedure, and then returns again. ## 2.5. How does the human SOUL “look like”?

It's a rather interesting question.



I try to answer this question with a question ... And how does the movie we are looking at a certain TV channel **look like**? Please carefully read this question once again. The question concerns not the film plot, not the main and lesser characters but something completely different ...

Having pondered this question, let's try to answer it (one of the possible answers):

The film on a TV screen **looks like** a lot of very small glowing and colored dots that are difficult to perceive by the eyes of **the human BODY** in isolation from one another, but together they represent the object under a conventional **movie** name. It was created by another object under the conventional **film company** name. The purpose of a movie is to change consciousnesses of the unformed human PERSONALITIES in accordance with the requirements of the film company owner.

100 years ago, the word “ILLITERATE” meant “unable to read and write”. That’s why such forms of art as cinema and circus conveyed the ideas of the country’s leadership to illiterate masses of the population.



100 years ago, the word “ILLITERATE” meant one thing, today it has a little different meaning, but the principle remained the same ...

Cinema, circus, social networks, SMS, MMS ... Modern researchers can easily continue this list ... Nothing has changed ...

So, what am I talking about? Oh, yes, how does the SOUL of a human being “**look like**” after all?

Let’s try to give possible answers by analogy with the television receiver:



## **The possible answer:**

Individual cognizes (perceives, manifests) the SOUL of a human being during communication and it “**looks like**” for him as a complex of socially significant features of the PERSONALITY of a human being (abilities, character, temperament, experience, skills, knowledge, etc.). He overcame these features through personal feelings and his attitude towards himself, the world, the surrounding objects and phenomena.

## 2.6. Why is creation of the HUMAN BEING called as CO-CREATION?

The creation of a human being is called CO-CREATION (joint creation) for a reason, because:

- The partners are involved in creation of the human body, sometimes they are called parents in society.
- The ENTITY of a human being has relation to appearance of the PERSONALITY of a human being inside the human BODY.

**CO-CREATION (joint creation) of a human being is a conventional name for the process of creating a human being, in which participate creators of the human BODY (parents, partners), and also creators and guardians of the ENTITY of a human being (the Creator, the White, the Gray).**



The terms the author connected with CREATOR, WHITE and GRAY terms he described in more detail in the Volume XXVI “The New Theory of Cosmic Eras” of “The New Cosmic Philosophy” book series (author’s note).



## 2.7. Can the SOUL of a human being be weighted?

Unfortunately, no one can measure the human SOUL, although it may be possible in the near future ...



Let's try to weigh the PERSONALITY of a human being. Imagine a TV set. If you understand the philosophy of creating and forming the PERSONALITY of a human being, then you can assert that to weigh a TV program in the TV set is the same thing as to weigh the PERSONALITY of a human being. It seems to be very simple – just turn your TV off and weigh it, then put on it and weigh once again. This difference will be the weight of a TV program inside TV. Besides, it may seem that TV program “leaves” this TV set when we turn it off!!!



Let's try to weigh the SOUL of a human being. The human SOUL is one's complex perception of the parameters of a human being through his own worldview. You can try to weigh the character traits, abilities or skills of a human being ... If you succeed, then in the future you will be able to weigh the human SOUL.

Death of a human being is the result of one of the following occurrences:

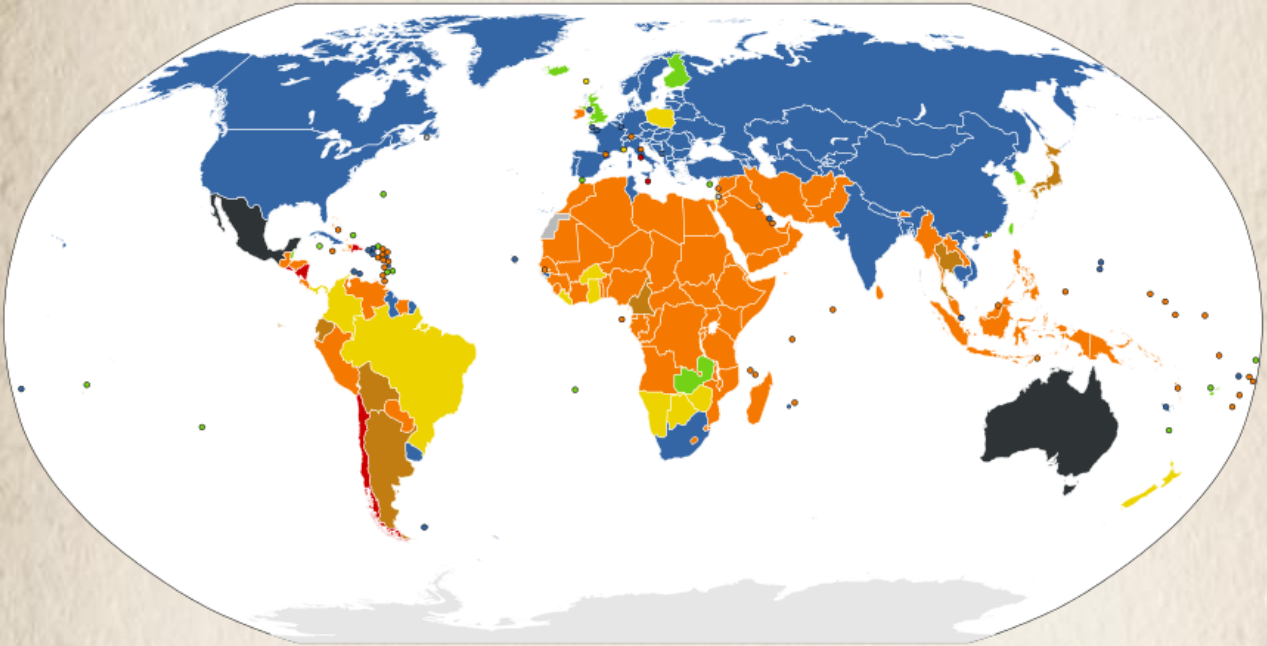
- Death of the human being BODY when it is decomposed into the objects having more elementary bodies.

 *Legal on request.*


 *Legal for maternal life, health, mental health, rape and/or fetal defects, and also for socioeconomic factors.*

*When it comes to legitimacy of abortion, all states can be divided into several groups:*

In Algeria, Argentina, Bolivia, Brazil, Ghana, Israel, Kenya, Costa Rica, Morocco, Mexico, Nigeria, Pakistan, Peru, Poland, Uruguay abortions are allowed if there is a threat to the life and health of a woman, that is, only for medical reasons. For example, in Spain, 1985 abortions were legalized in cases of rape, serious fetal defects and risks for the physical or mental health of a woman.*



4. *Abortion for medical and socio-economic indications. In England, India, Iceland, Luxembourg, Finland, Japan, abortion is allowed only for medical and socio-economic grounds, as well as in cases of rape.*
5. *Freedom of abortion. In the most liberal countries, the legislator relies on the recognition of a woman's right to make her own decisions about pregnancy. The criminal policy is aimed at protecting women's health, that is, only out-of-hospital and late-term abortions are legally prohibited. In the early stages of pregnancy, "if desired", abortions are allowed on the territory of the CIS and the Baltic States, in the former Yugoslav republics, Australia, Austria, Albania, Belgium, Bulgaria, Hungary, Vietnam, Germany, Greece, Denmark, Italy, Cambodia, Canada, China, Cuba, Mongolia, the Netherlands, Norway, Russia, Romania, Singapore, Slovakia, USA, Tunisia, Turkey, France, Czech Republic, Sweden, South Africa.*

ABORTION really reached dangerous proportions. Hungary's Constitution of 2011 adopted that the human life begins from the time of conception, and abortion, in fact, is equated with a murder of a human being.

*"Abortion is the ending of pregnancy due to removing an embryo or fetus before it can survive outside the uterus. According to modern medical standards, abortion is usually performed at up to 20 weeks of pregnancy or if the period of pregnancy is unknown and the fetus weighs up to 400 g."*

**Can a pregnancy be terminated?**

**The answer is YES!**

Before cutting the navel string (umbilical cord), the body of a FETUS represents the integral part of a mother's body. And abortion performed in any period up to this moment cannot be considered as a murder, because there is no **fully formed** human being yet. ### **3.2. What can be the object's identifier for an individual?**

- A print of energy.

### **3.3. Can the human beings become IMMORTAL?**

The question is inaccurate. The structure of A HUMAN BEING includes many objects. Thus, it's hardly understandable what or whom is being talked about?

*“Cryonics (from Greek κρύος kryos meaning ‘cold’) is the low-temperature preservation (usually at  $-196^{\circ}\text{C}$ ) of human cadavers, with the hope that resuscitation and restoration to life and full health may be possible in the far future. Cryopreservation of humans is not reversible with present technology; cryonicists hope that medical advances will someday allow cryopreserved people to be revived.*

*Cryonics is regarded with skepticism within the mainstream scientific community and is not part of normal medical practice. It is not known if it will ever be possible to revive a cryopreserved human cadaver. Cryonics depends on beliefs that the frozen body has not experienced information-theoretic death. Such views are at the speculative edge of medicine.*

*Cryonics procedures can only begin after legal death, and cryonics “patients” are legally dead. Cryonics procedures ideally begin within minutes of death, and use cryoprotectants to prevent ice formation during cryopreservation. The first corpse to be cryopreserved was that of Dr. James Bedford in 1967. As of 2014, about 250 bodies were cryopreserved in the United States, and 1,500 people had made arrangements for cryopreservation after their legal death.”*

3.5. Is the human SOUL “mortal”?

### 3.8. Can the SOUL “be put” over and over again?
