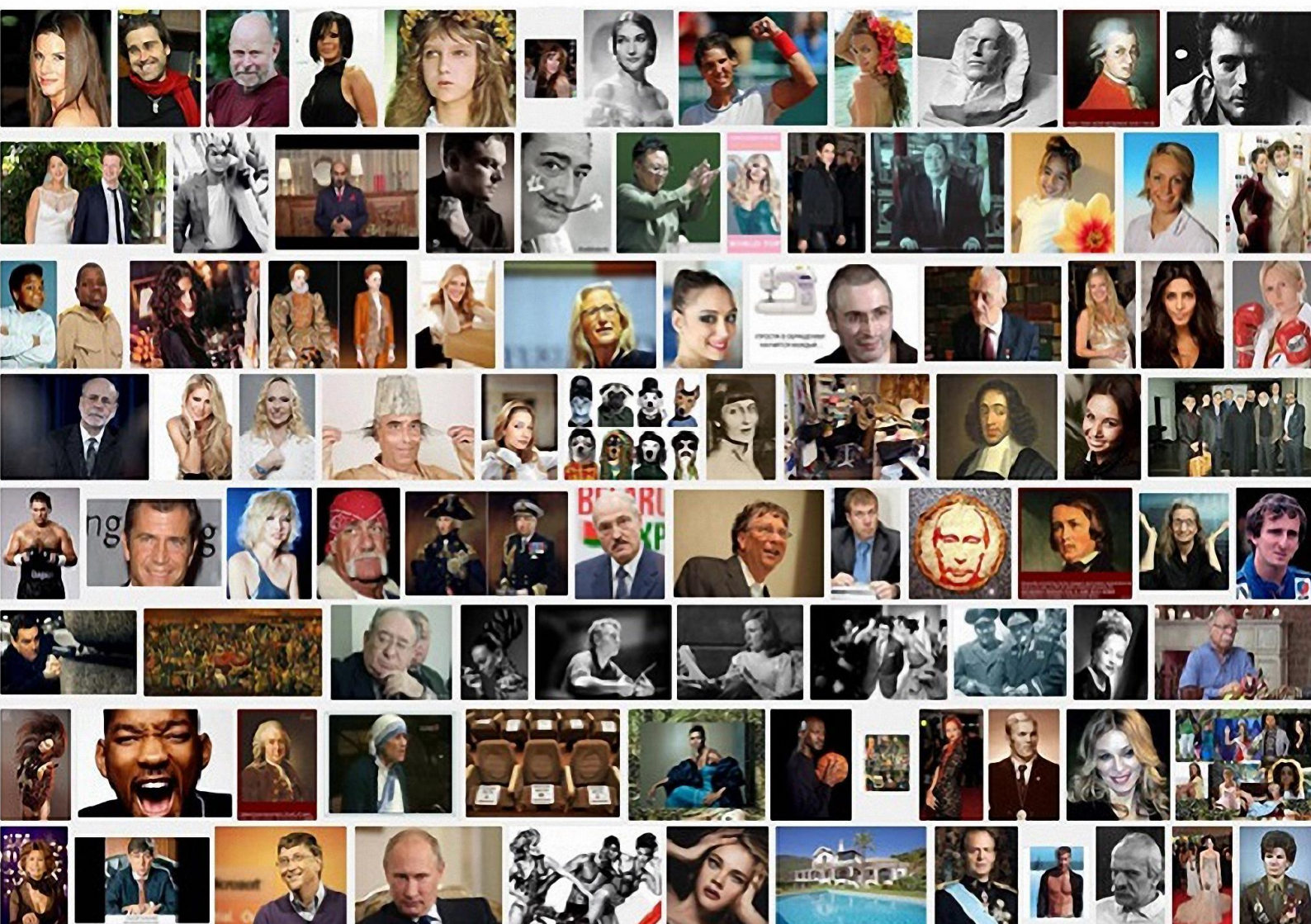


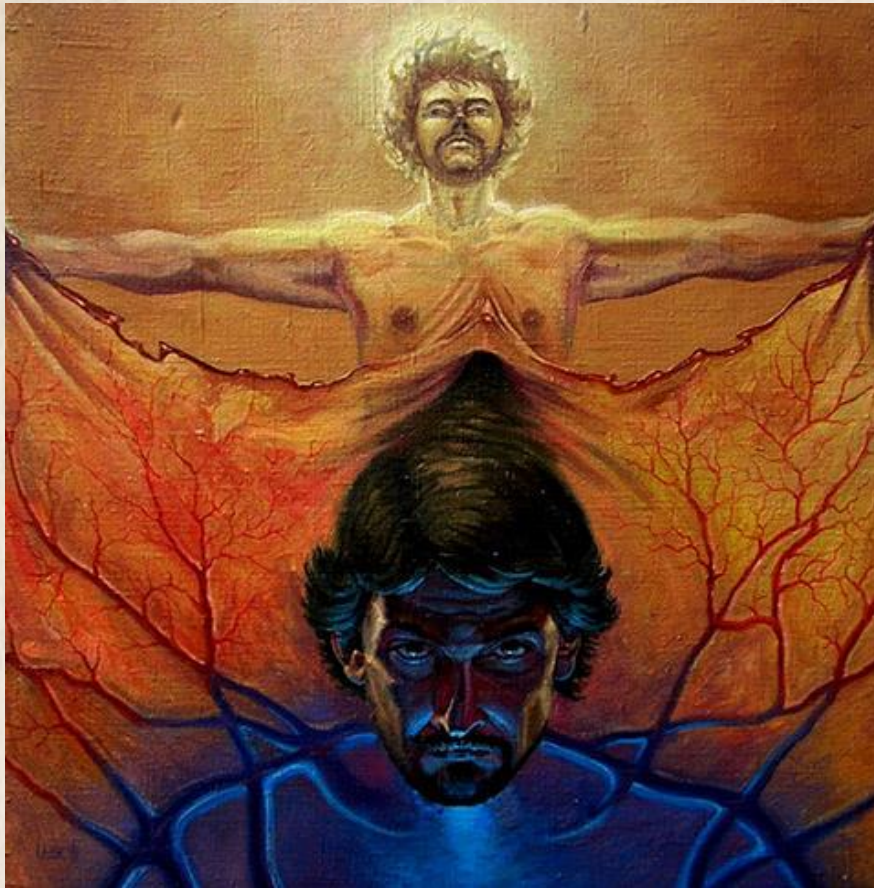

1. The PERSONALITY of a human being
- 1.1. The definition

THE PERSONALITY of a human being is one's manifestation of the states of the human ENTITY that has incarnated into the human BODY on condition of the main embodiment. An individual sees (feels) these states as the socially important stable characteristics of a human being (aptitudes, character, temperament, experience, skills, knowledge, etc.).

1.2. Birth of a new PERSONALITY of a human being

- The ENTITIES of the human beings (“the Selves” of the human beings) are technologically identical.
- The human BODIES are constantly residing at a field of ENTITIES of the human beings.
- The human BODIES resonate in a field of ENTITIES of the human beings (“The Selves” of the human beings) where manifest the PERSONALITIES of the human beings.
- The ENTITY of a human being radiates the carrier frequency, which forms the PERSONALITY of a human being, it’s individual for each new incarnation.
- The bandwidth of a resonant circuit is determined by the human BODY and represents a standard constant value.

- The new PERSONALITIES of the human beings have no CONSCIOUSNESS (at all), since they haven't yet realized anything and haven't systematized anything during their life cycle, i.e. their memory is empty.
- A new PERSONALITY of a human being will work with his individual MEMORY (as a device) in the frequency range determined by a resonant frequency and a bandwidth.
- A new PERSONALITY of a human being will work with his individual MEMORY (as data, i.e. CONSCIOUSNESS).
- A new PERSONALITY of a human being will work with his individual MEMORY (as a place of the systematized data storage).

1.3. The stable characteristics of the PERSONALITY of a human being

Since the PERSONALITY is a complex of all properties and socially significant characteristics of a certain human being, so, there can be a lot of such characteristics. Every country has its own views: one society pays attention to certain people traits, another one – to completely different characteristics. In each case, these characteristics of the PERSONALITIES of the human beings will be called as socially significant ones, regardless of their diversity.

Many characteristics become stable, although they can change with age of the human body.

Such characteristics of the PERSONALITY can include:

- Temperament;
- Character;
- Aptitudes;
- Skills;
- Experience;
- Knowledge;
- etc.

1.4. The modern identification of a human being

Unfortunately, it's impossible to provide a clear identification of a human being, based only on his body parameters. A simple cosmetic operation and you will not recognize a human being you know before. Thus, the parameters of the BODY and the PERSONALITY are used altogether to solve this problem. In addition, due to these parameters every human being becomes an INDIVIDUAL.

When people assert that they know this “man” (to be more precisely, a human being), it means that they have identified this human being according to two interconnected components:

- They know how the BODY of a human being looks like, which the ENTITY of a human being has incarnated into.
- They know the PERSONALITY of a human being, which they associate with this body as a complex of its stable characteristics.

If at least one of the mentioned above components is changed, people will not recognize this human creature (“a human being”).

This can happen in the following cases:

- the BODY has been changed (plastic surgery, body injuries, etc.);
- The PERSONALITY has been changed (for some reason, stable characteristics of the PERSONALITY have been changed (a human being acquires new knowledge and aptitudes or loses some knowledge and aptitudes he had before)).

Based on the mentioned above information, we can assert that people identify each other according to two interrelated components: the BODY and the PERSONALITY of a human being.

1.5. AWAKENING, THE AWAKENED

one who was done with AWAKENING.**

AWAKENING is the first step towards ENLIGHTENMENT, i.e. towards cognition of the true reality of "our" World.

1.6. ENLIGHTENMENT, THE ENLIGHTENED, INITIATION

**ENLIGHTENMENT is
one's fulfilment of INITIATION.**

**ENLIGHTENED is
one who was done with ENLIGHTENMENT.**

**INITIATION is
one's (the Personality of a human being) realization
of the fact that in the Universe there is a certain
Source and the principal possibility of cooperation
with it.**

1.7. THE HUMANKIND is ...

It's difficult to finish this title because THE HUMAN BEINGS consist of many components (objects, organisms, creatures, entities ...), so, all THE HUMANKIND can be represented as the same components.

**THE HUMANKIND is
a complex of PERSONALITIES of the human beings
ever existed in the human BODIES.**

**THE HUMANKIND is
a complex of all human beings with the modern
bodies both existed earlier or existing now on the
Earth.**

Human beings, mice and cockroaches living on the Earth can consider themselves as EARTH DWELLERS, as inhabitants of the planet. But they cannot consider themselves as the Earth.

In the same way, bacteria living in the human body cannot consider themselves as the human beings. They can consider themselves only the inhabitants of the human body. The inhabitants of the BODY, for example, of Ivan Stepanovich Petrov.

The questions that have to be answered are:

- Is it correct to perceive THE HUMANKIND only as lots of different objects, considering that we as individuals associate these objects with the human bodies?
- Is it possible to perceive THE HUMANKIND as “invisible” ENTITIES, which incarnate into the human bodies either on condition of the main or the simple embodiment?
- Etc.

The author sticks to the point of view that the most appropriate definition of the word HUMANKIND for today is the following:

**THE HUMANKIND is
a complex of all INDIVIDUUMS
lived earlier or living now on the Earth**

or

**THE HUMANKIND is
a complex of all ENTITIES of the human beings ever
incarnated into the human BODIES on condition of
the main embodiment.**

That's why:

Firstly, individuals connect the concept "HUMANKIND" with people, and the latter with the human BODIES. Today individuals use the images of the human BODIES (photos, portraits, drawings, pictures, etc.) or any other parameters (physical, biochemical, etc.) to identify the human beings.

Secondly, the concept HUMANKIND is connected with the PERSONALITIES of human beings, which create their CONSCIOUSNESS. And lots of CONSCIOUSNESSES of the human beings are nothing more than CONSCIOUSNESS of all THE HUMANKIND.

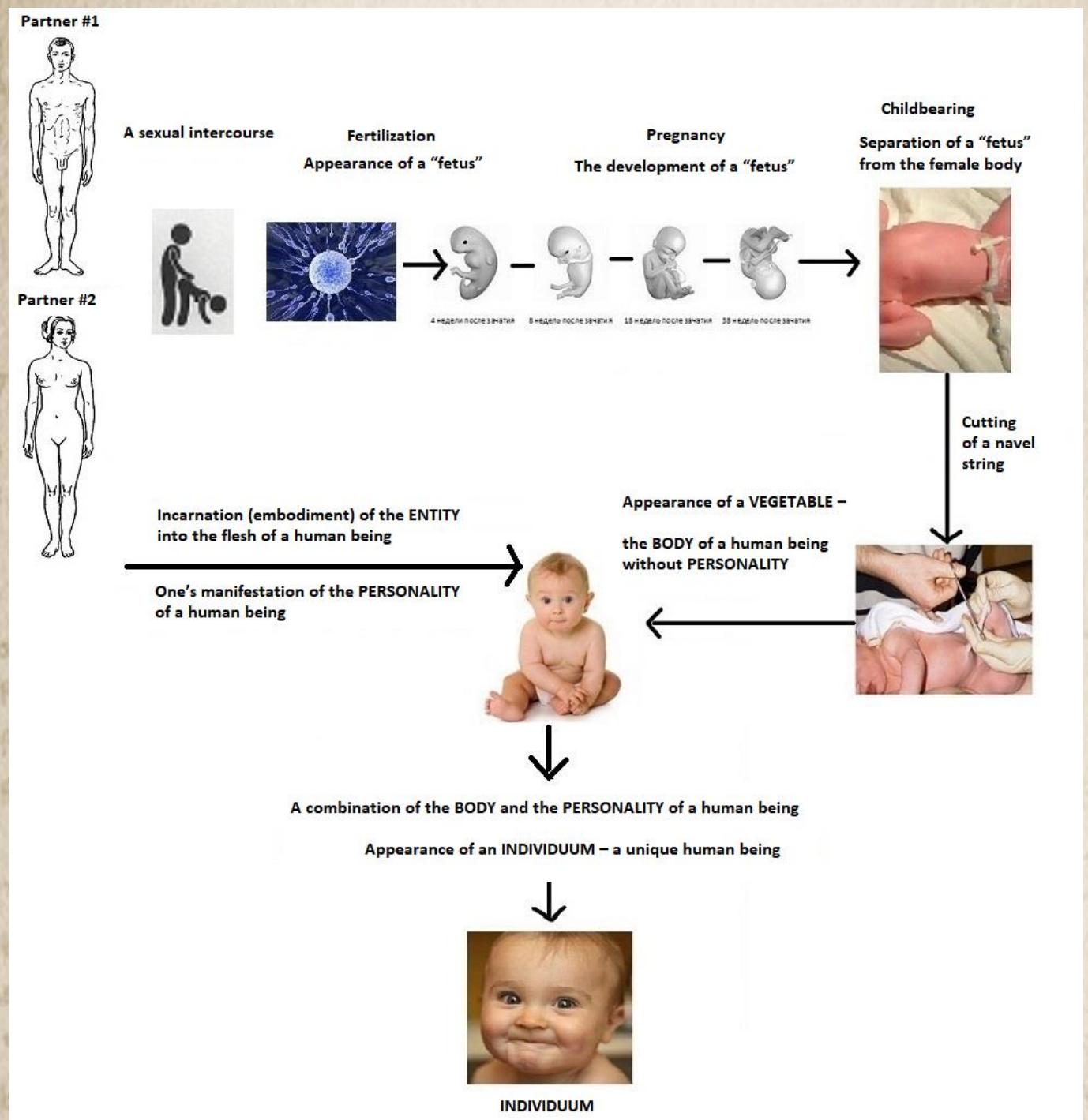
Thirdly, the concept HUMANKIND is connected with the Earth as with the current place of living. Many thousands of years ago a completely different place in the Universe could be the place of living for the Humankind. Considering that "absolute death of a CREATURE is the loss of information about it in CONSCIOUSNESS of the certain population", then it can be asserted that in this case it's ANOTHER (DIFFERENT) "HUMANKIND".

2. AN INDIVIDUAL

**AN INDIVIDUAL is
a conventional name of a human being having
individuality, i.e. the unique BODY and the unique
PERSONALITY.**

The moment of an INDIVIDUAL creation, i.e. the moment of appearance of the PERSONALITY inside the human BODY is the end of the human being's ENTITY incarnation into the human BODY. This process is called CREATION (CO-CREATION, a joint creation), because parents, in other words, partners participate in creation of the human body. And creation of the PERSONALITY of a human being depends on an entirely different object under the conditional ENTITY of a human being name.

2.1. The block diagram of an INDIVIDUAL creation



The block diagram of an INDIVIDUAL creation, i.e. a human being with INDIVIDUALITY (the unique BODY and the unique PERSONALITY)

The block diagram demonstrates some mystery – the birth of the PERSONALITY of a human being (which can be manifested on a child's face) with a clear as white sheet CONSCIOUSNESS (MEMORY). A human being begins to fill it and will do this until the end of his days.

2.2. THE LIFECYCLE of individual



The block diagram of a lifecycle of INDIVIDUAL

You can definitely ask why the LIFE of a human being is called a LIFE CYCLE. The answer is quite simple: the object under the conventional INDIVIDUAL name was created not by the human beings.

**A LIFE CYCLE is
a period of time from the Maker`s (the Author`s)
decision to create an object and til this this object
will be out-of-operation.**

From time to time, the bodies of human beings of different genders “force” their programs for getting pleasure to copulate. That’s all...

The bodies of two human beings of different sex just PARTICIPATE in sexual intercourse, as a result of which they **conceive** a child. As for conceiving and development of A FETUS, these processes continue without the knowledge of people. For today, the representatives of scientific community make every effort to study this process in more detail.

And such “parts” of a human being called by people themselves as SOUL and PERSONALITY, in general, “come from nowhere” in their view during birth and “disappear somewhere” when the body of a human being is dead.

If we assume that a human being is the object of a life cycle, then the main periods of his/her life cycle may look something like this:

- **Pregnancy.** The development of a zygote into an embryo and then into a fetus in preparation for childbirth.
- **Infancy.** The earliest part of childhood. It is the period from birth through age one.
- **Toddler years.** Occur during ages two and three and are the end of early childhood.
- **Childhood.** Takes place from ages four to eight.
- **Puberty.** The period from ages nine to thirteen, which is the beginning of adolescence.
- **Older adolescence.** The stage that takes place between ages fourteen and eighteen.
- **Adulthood.** The period from adolescence to the end of life and begins at age nineteen.
- **Middle age.** The period of adulthood that stretches from age thirty-one to fifty.
- **Senior years, or old age.** Extend from age fifty-one until the end of life.

2.3. The free-will change of INDIVIDUALITY

Today many PERSONALITIES of the human beings inhabit several realities. Computer games, meditations, alcohol, drugs, various chemical substances, etc. are the reasons for it.

Radio, television, press, films create the so-called virtual Worlds...

There was a reason for appearance of such a concept as “a free-will refusal of one’s own body” that means a human being is less than enthusiastic about developing his own body. The human beings do a plastic surgery, piercing, tattoo, scarring, damage, etc. to modify their bodies.

In presentations, videos, advertising ... well known people are replaced with artists, stump doubles, bump artists ...

But these are the PERSONALITY and the BODY of a human being his true individuality is created by.

What can be the consequences of a voluntary change of INDIVIDUALITY, nobody knows yet. Modern scientists are well aware of the results caused by prolonged use of drugs or excessive enthusiasm for computer games

("hovering" in the virtual world). They lead to serious diseases of the human body, and today it's rather difficult to achieve a positive result after treatment.

3. The possible abnormalities during formation of the human beings' PERSONALITIES

3.1. MultiPERSONALITIES of the human beings or Milligan's effect

The pillar of many today scientific researches is a scientifically confirmed and well documented fact about twenty-four ENTITIES of a human being inside one human BODY. As a result of their periodical replacement, everything looked like replacement of the PERSONALITY of a human being.

["William Stanley Milligan"](#) (February 14, 1955 – December 12, 2014) was an American citizen who was the subject of a highly publicized court case in Ohio in the late 1970s.

After having committed several felonies including armed robbery, he was arrested for three rapes on the campus of Ohio State University. In the course of preparing his defense, psychologists diagnosed Milligan with multiple personality disorder. His lawyers pleaded insanity, claiming that two of his alternate personalities committed the crimes without Milligan being aware of it. He was the first person diagnosed with multiple personality disorder to raise such a defense, and the first acquitted of a major crime for this reason, instead spending a decade in mental hospitals.



*Milligan's life story was popularized by Daniel Keyes's award-winning non-fiction novel *The Minds of Billy Milligan*.*

In 1975, Milligan was imprisoned at Lebanon Correctional Institution in Ohio for rape and armed robbery. He was released on parole in early 1977 and was required to register as a sex offender. In October 1977, Milligan was

arrested for raping three women on the Ohio State University campus. He was identified by one of his victims from existing police mug shots of sex offenders, and from fingerprints lifted from another victim's car. One of the victims said that he was quite nice and that he acted like a 3-year-old girl.

Since he used a gun during the crime and guns were found in a search of his residence, he had violated his parole as well. He was indicted on "[...] three counts of kidnapping, three counts of aggravated robbery and four counts of rape". He then stayed in the Ohio State Penitentiary.

In the course of preparing his defense, he underwent a psychological examination by Dr. Willis C. Driscoll, who diagnosed Milligan with acute schizophrenia. He was then examined by psychologist Dorothy Turner of Southwest Community Mental Health Center in Columbus, Ohio. During this examination, Turner concluded that Milligan suffered from multiple personality disorder. Milligan's public defenders, Gary Schweickart and Judy Stevenson, pleaded an insanity defense, and he was committed "[...] until such time as he regains sanity".

Billy Milligan had a number of personalities:

The Ten

These ten are the alters whom personalities "Ragen" and "Arthur" decided were not "undesirable". They freely shared consciousness, and doctors quickly learned of their existences.

Billy Milligan (William Stanley Milligan) is the core personality, or "waking" self.

Arthur is an extremely sophisticated and educated Englishman. An expert in science and medicine, with a focus on hematology. He is in "the spot" – that is, in charge of the shared body – during times that required intellectual thinking. Arthur is one of only two personalities who could classify a person in the group as an undesirable.

Ragen Vadascovinich is the “keeper of hate”. His name comes from the words “rage again”. Ragen describes himself as Yugoslavian, has a Slavic accent, can write and speak in Serbian and is extraordinarily strong. He controls the spot in dangerous times and can designate group members as “undesirable”. He admitted committing robbery in order to support “the family”, but had no knowledge of the rapes.

Allen is a con man and a manipulator. He is the most common person to talk to the outside world. He plays the drums and paints portraits. Also, the only right-handed self. He is the only personality that smokes cigarettes.

Tommy is the escape artist; he is often confused with Allen. He plays the tenor sax and is an electronics expert. He is also a painter, specializing in landscapes.

Danny is afraid of people, especially men. He only paints still lifes and never paints landscapes. He says this was because Chalmer made him dig his own grave and buried him in it.

David, age eight, is the “keeper of pain”. He comes to the spot to take the pain of the others.

Christene, age three, was the one who would stand in the corner in school when “Billy” would get in trouble. She has dyslexia, but Arthur taught her to read and write. Ragen has a special bond with her.

Christopher, Christene’s brother, plays the harmonica.

Adalana, a lesbian, cooks and cleans house for the others, and writes poetry. Milligan’s attorney claimed that Adalana had admitted to committing the rapes without the knowledge of Milligan or the other alters.

The Undesirables

These people were labeled “undesirable” after breaking the rules laid down by Ragen and Arthur. These alters were no longer allowed “on the spot” (that is, to hold consciousness) and only revealed themselves after Milligan was sent to the hospital.

***Phil** is a thug and took part in planning some small-time crimes. Has a Brooklyn accent. Marked due to him being a criminal.*

***Kevin** is a criminal planner; he helped devise a plan to rob a drug store. Labeled also because he is a criminal.*

***Walter** is Australian. He calls himself a big-game hunter and has an excellent sense of direction. Was often used as a spotter. He was labeled because he shot and killed a crow.*

***April** only has thoughts about destroying Billy’s stepfather. Declared an Undesirable when she convinced Ragen to kill Chalmer. Arthur was able to talk him out of it just before the tragedy.*

***Samuel** is a Jewish person and the only one who believes in God. Was marked because he sold some of the other people’s personal paintings.*

***Mark** of the Caves is the workhorse. He is often referred to as the zombie because he does nothing unless he is told, and will stare at walls when bored.*

***Steve** is the impostor, he uses imitations for comedy. Steve never accepted that he was an MP. He was made to be undesirable because his comedy caused the family problems.*

***Lee** is the prankster and his practical jokes normally get the family into trouble. He does not care about consequences for his actions. He was made an undesirable because one of his jokes put them into solitary confinement.*

Jason is the pressure valve. He was used at the beginning to release tension for the family, but he caused them to get into too much trouble and was marked as an undesirable.

Bobby always dreams of leading some adventure or fixing some global crisis, but he has no ambitions and was labeled due to that fact.

Shawn, who is four and deaf, makes buzzing sounds so he can feel the vibration in his head. He was labeled an undesirable because there was no benefit from being deaf later on in life. (Even though he is an undesirable he was never cast into the shadows beyond the spot; he was just never allowed to take the spot.)

Martin is a snob, from New York. He wants things just handed over to him without earning them.

Timothy worked in a florist shop until he encountered a gay man who flirted with him. He went into his own world after that.

The Teacher

(Not an Undesirable)

The Teacher, who was the “memory trace” of Milligan’s selves, was by far the greatest milestone to helping Billy achieve fusion. He is the sum of all 24 people put together, and has almost total recall of all the other people’s actions and thoughts.

The scientific community investigated the main thing: the objects inside William Stanley Milligan’s body could fully control it **only one by one**.

But if several ENTITIES of the human beings can get the complete control over one and the same body of a certain human being - even if one by one - this will lead to improper functioning of a human being as a social object.

The representatives of modern medicine call it as “cloning” (splitting, disfunction, etc.) of the personality and today there are many methods of treating this “disease” without understanding the essence of this phenomenon.

A MULTIPLE INCARNATION is the situation when many ENTITIES of the human beings incarnate into the human body. One of these entities incarnates on the terms of the main embodiment and the rest – on condition of the simple incarnation. Periodically, they exchange the control over the human body to each other.

“Dissociative identity disorder (DID), also known as multiple personality disorder, is a mental disorder characterized by at least two distinct and relatively enduring personality states. There is often trouble remembering certain events, beyond what would be explained by ordinary forgetfulness. These states alternately show in a person’s behavior. Presentations, however, are variable. Associated conditions often include borderline personality disorder, post traumatic stress disorder, depression, substance misuse disorder, self-harm, or anxiety.

The cause is believed to be due to childhood trauma. In about 90% of cases there is a history of abuse in childhood, while other cases are linked to experiences of war or health problems during childhood. Genetic factors are also believed to play a role. An alternative hypothesis is that it is a by-product of techniques employed by some therapists, especially those using hypnosis. Before a diagnosis is made, it should be verified that the person's condition is not better accounted for by substance abuse, seizures, imaginative play in children, or religious practices.

Treatment generally involves supportive care and counselling. The condition usually persists without treatment. It is believed to affect about 2% of the general population and 3% of those admitted to hospitals with mental health problems in Europe and North America. DID is diagnosed about six times more often in females than males. The number of cases increased significantly in the latter half of the 20th century, along with the number of identities claimed by those affected."

Milligan's case looks as if inside his body there were a lot of resonant frequencies at the same time. Theoretically, it happened because a bigger number (than usually) of the ENTITIES of the human beings simultaneously saw the "unoccupied" body of Milligan and were quick to inhabit it.

There are many well-documented cases when individual unexpectedly acquires previously absent aptitudes and knowledge. We are talking about knowledge and skills the personality of a human being acquires during many years study. As an example, ability to play various musical instruments, knowledge of

foreign languages, ability to write the works of art, drawing abilities and so on ... the tendency to learn exact sciences and ability to work out complex mathematical tasks ...

Sometimes “new” skills and abilities appear when DNA of one human BODY penetrates into/on another BODY of a human being, namely:

- transplantation;
- blood transfusion;
- cannibalism;
- wearing of head falsie made of natural hair;
- wearing of secondhand;
- etc.

In these cases, people often have unusual dreams, gain extraordinary capacities that indicates presence of other ENTITY inside their bodies. This ENTITY appears as a result of a resonator and its body has another resonant frequency. The power of this resonator is far less, that’s all ...

As a result, the scientific community doesn’t fully investigate these processes, although the Internet is full of such kind of information.

After all, the Indians were right to eat Cook.

But if transplantation or blood transfusion produce a long-term effect, then cannibalism is of a short-term effect ...

By the way, in Nepal people aren't buried, but cut into pieces and eaten by the eagles. Since ancient times, these people believe that the PERSONALITY of the dead incarnates into the eagle this person was eaten by, i.e. the ENTITY of a human being will resonate in the eagle body and the "PERSONALITY of the dead" will see his own funeral from a bird's eye view...

3.2. THE PERSONALITIES of non-human Entities

These are rare instances when the ENTITY of a non-human being (instead of the ENTITY of a human being) incarnates into the human body. As a rule, it's a study object of EXORCISTS.

3.3. A VEGETABLE or a human being as a plant

According to many data get leaked to the Internet, intelligence agencies around the world have developed numerous techniques and learned how to “destroy the memory” of a human being. These attempts are most likely to explain a lot of incidents when people who “lost their memory” are found in many countries even today.

But without understanding the philosophy of this process, without realizing inability to destroy the MEMORY OF THE PERSONALITY of a human being, they just use various methods to make an access to it mode difficult. While the BODY of a human being is accessible for manifestation, then it's always possible to restore its MEMORY!

The human BODY isn't considered dead without the PERSONALITY of a human being, it turns into an object under the conventional VEGETABLE name (another name is “a human being as a plant”).

A VEGETABLE (a human being as a plant, the first variant) is a conventional name of a human being with the brain damage leading to such improper functioning of the PERSONALITY of a human being when he/she loses access to its own MEMORY (CONSCIOUSNESS).

A VEGETABLE (a human being as a plant, the second variant) is a conventional name of a human being with the dense BODY, inside of which takes place excarnation of the previous ENTITY of a human being due to some reasons. So, there was incarnation of a new ENTITY of a human being (as during the birth of a new body). All this leads to appearance of a pure CONSCIOUSNESS (MEMORY), which will be filled by the newly-born PERSONALITY of a human being from ground zero, as if it was a newly-born child.

How does it look like? The body seems to work properly. The body is able to respond, i.e. a person withdraws his hand from the hot, the eye reacts to a bright flash of light ... And nothing more.

The medical practitioners can pronounce:

- a total loss of the object's memory (one forgets the name, the place of living, etc.);
- a total loss of life experience (I emphasize A TOTAL LOSS). Thus, this human being has experience of a newly born child.

The total loss of life experience means that object doesn't know any words, the names of objects, doesn't remember his relatives, etc. He should start from the

very beginning, as a newly born child does by explaining what is a table and a chair, a cucumber and a tomato. How does this or that object smell. What is the meaning of this or that word.

People who are acquainted with a vegetable can help this person to restore his CONSCIOUSNESS to some extent. He definitely couldn't restore all the previously systematized information, but only a certain amount of it.

ZOMBIES differ from the humans who are plants by the possibility to be used for ones' deceptive purposes they are placed an order by ...

Today there is a slightly different definition of the concept ZOMBIE (from Greole - zonbi, northern mbundu - nzumbe) that doesn't contradict the definition of the word VEGETABLE, namely:

**ZOMBIE is
a human being who doesn't control his own body
and obey one's order against his will.**

3.4. Replacement of the PERSONALITY of a human being

From time to time, there can be some disturbances during incarnation ... This is the case of dying of the human body, that is disappearance of the resonant circuit. As a result, the ENTITY of a human being “leaves” the human BODY, i.e. the PERSONALITY of a human being disappears ...

If the human BODY begins to work in proper way, it means that into the unoccupied human body can incarnate:

- the previous ENTITY of a human being;
- a new ENTITY of a human being.

The mentioned above cases depend on changes of the parameters of a resonant contour of the human body.

Thus,

- probability of “return” of the previous unchanged PERSONALITY. In such a case, people around will take no notice of any changes of this individuum;
- probability of “return” of a slightly modified PERSONALITY. In this case, others may notice changes of this individuum, because he may suddenly demonstrate knowledge and abilities he hasn’t possessed before;

- probability of appearance of a “completely new PERSONALITY”. In this case, others will see “replacement” of the PERSONALITY of a human being:

- If the PERSONALITY of a human being has already been formed at this resonant frequency, then its knowledge and experience will be manifested;
- If the PERSONALITY of a human being has never been formed before at this resonant frequency, then will appear an object under the conventional VEGETABLE name with the memory of a newly born child, i.e. without memory at all.



Other people see it in another light:

The person was involved in a crash (suffered a clinical death, lightning stroke or electric shock, etc.), i.e. “suffered term death”, and then “was born again”. And he significantly changes for some unknown reason. He acquired abilities he had never had before. He began to play the violin, to write poetry, i.e. “was no longer himself”. This event is popularly called as THE SECOND BIRTH.

We already know a lot of documented situations related to this topic, you can see some of them on YouTube.

“During the 1970s people wrote a lot of the case of 12-year-old Elena Markard from West Berlin. After severe injury, she suddenly spoke fluent Italian after

regaining consciousness, although before she didn't know it at all. This girl remembered her Italian life and name – Rosetta Rostellani. She also recollected her own death at the age of 30. During a trip to Italy with scientists who were interested in this case, she immediately recognized and called by the name her elderly daughter.

There are lots of such cases, but in the 1940s David Pelendain mind-blowned all scientific world of the United States.

David was born and raised in Arizona. He was a son of a white missionary and Indian woman. As a child, being educated in the reservation for the Indians, he was behindhand in diligence – he was sent to a correctional school twice. During the Second World War, he happened to be in Europe as a soldier. Then German captivity, starvation, tortures ... When the British soldiers liberated prisoners from the concentration camp, they found his body without any signs of life. Together with other dead bodies, it was sent for burial. But during identification, his body was found to be still alive ...

Then he was hospitalized in Austria, the USA. He returned to consciousness only after 2.5 years and to the question who is he, the young man answered: "I am an artist, my name is Wassily Kandinsky". It could be taken as nonsense, because the famous Russian artist W. Kandinsky died in Paris in 1944 at age 78.

But David Pelendain (his name was identified by his fingerprints) behaved oddly. A young man spoke fluent Russian, without any accent, as educated person, considering that he never knew this language before. Then he was consumed with desire to paint. In the hospital, he began to create pictures. When art experts saw his paintings, they unanimously asserted that they represent the style and the symbolism of Kandinsky.

Then David began to play the piano and arrange various compositions for the local orchestra. Later, with his six classes of education, Pelendain became a teacher of theology at the University of Denver.

His friends advised him to visit a hypnotist. There is a real voice of Kandinsky with a clear Russian accent on the tape recorder where David told that the artist's soul breathed life into his body died as a result of beatings and tortures.

In the 1990s, David Pelendain still lived in Albuquerque and, as the press reported, had his own art studio. The director of the New York Museum has a big collection of Kandinsky's paintings and sticks to the point of view that the works of David are nothing more than creative heritage of Wassily Kandinsky."
